Sub: Issue of Essentiality Certificate under rule 44 of Delhi School Education Act, 1973.

Sir,

With reference to your application on the subject cited above, I am directed to convey the permission of the Director, of Education, Delhi to your society to establish a new school from Class Ist to VIII (Without aid) in BUDH VILAR, ZONE-III DE Distt. North

1. That the provision of DSE/R, 1963 and the rules framed thereunder shall be observed by the society.
2. That the management of the school will fulfill all the conditions laid down under rule 50 and will provide all the facilities given in rule 51 of DSE, 1973 to the institution.
3. That the management of the school will get the scheme of management approved from the department immediately.
4. That the only qualified and trained teachers will be appointed Govt. scales alongwith all allowances will be paid to the teaching and non-teaching staff through crossed cheque.
5. That the management of the school will not ask for grant-in-aid from the department.
6. That the school will not run for the profit of any individual association or group of persons.
7. That in case at any time the management of the school is unable to run the school movable and non-movable property of the school will be transferred in the name of Director of Education.
8. That all the recognised classes shall be run at one place only.
9. That the management of the school will not get grant of recognition of the school under DSE/R, 1973 and recognition will not be granted unless statutory provisions of section 4(1) to (6) read with rules 30 and 51 are fulfilled.

10. That the school shall be run under the control of.....
PRINCE EDUCATIONAL SOCIETY..... and suitable funds will be
made available for the construction of suitable building on
the land allotted to the society, as declared as per the speci-
fications of the department with a period of three years.
11. That the management of the school will obtain land from DDA
in the name of the society through Directorate of Education, Delhi
and shall construct a school building thereon for the proposed
school as per specifications of the deptt.
12. That the school shall have adequate and sufficient accomodations of
13 sq. ft. per student staff be provided for class-room. The norma
size of class-room will be 24' x 30'. No other activities other
than education shall be run.
13. If the recognition for the proposed school is not sought
within a period of three years, this permission to run a new school shall be
treated as cancelled.
